PLANNING

GENERAL PLANNING

- Reviewed 125 development applications
- Made 15 objections on the basis of LNP criteria & 30+ comments
- Gaywood Solar Farm application: consultation with all parties and objection submitted
- Hillview Farm - successful objection on basis of need to retail rural economy / employment

Particular interest is being paid to:

- Number of applications for "annexes" - these should be *ancillary* to main accommodation
- Retaining street scene with hedges and soft boundaries



Surrey Hills

AONB REVIEW

- Reviewed the boundary and submitted 6 areas for consideration to be included within the revised AONB area: West Heath, Limpsfield Common, Scearn Bank, Caxton, Swaynesland and Tenchleys
- All areas submitted are being considered
- Consultation finishes 13th June



HERITAGE ASSETS LIST

- Reviewed current English Heritage listed buildings and locally listed buildings
- Submitted 17 assets for consideration - including buildings, ponds, air raid shelters
- Confident that most of our submissions are included
- Awaiting final decision and publication of 2023 list by Tandridge District Council

LNP INITIATIVES FY23

- Continued focus on improving our footpaths, bridleways and recreational areas
- Consultation and funding commitment for Oxted CCTV system
- Working with Friends of Limpsfield Common, Titsey & National Trust re. biodiversity
- Creation / Completion of the Limpsfield Way & Cycle Route
- Ongoing consultation with SCC on local highways matters



THE LIMPSFIELD WAY & COMMUNITY CYCLE ROUTE

Funded by Your Fund Surrey, we now have:

- A 4.5-mile circular walk and "there and back" cycle route linking Limpsfield Village to Limpsfield Chart
- Rest & Play area near New Road & easy access pathway
- 2 Information boards and 4 History boards along the route
- Waymarking and signage
- Surface improvements of key routes across Limpsfield Common/Chart
- Online maps and interesting information at www.limpsfield.org/limpsfield-way



LVCAAMP

- The **Limpsfield Village Conservation Area Appraisal & Management Plan** (LVCAAMP) is now a Supplementary Planning Document (SPD) adopted by Tandridge District Council
- We have started to create a management plan for the Limpsfield Village Conservation Area (LVCA)
- Activity to date includes:
 - the replacement of bins in the conservation area with more appropriate black bins
 - the addition of the ancient replica milestone opposite St Peter's Church.
 - We have begun initial investigations into the renovation of the ironstone cobbles and paving within the Village Conservation Area.
 - Draft of pamphlet for residents and businesses





FINANCE

CONSERVATIVE & RESPONSIBLE BUDGETING

- Prudent Reserve of £16,658 – 50% Parish Precept
- Ring-fenced Limpsfield Chart account; includes £10,000 reserve for playground decommissioning & repairs and / or replacement of equipment
- Unless confirmed in advance, we assume zero Community Infrastructure Levy (CIL) income due to uncertainty of amount and timing of payment
- We assume low VAT reclaim amount
- Planned spending includes VAT (which is ultimately refunded) and 5% contingency
- We earmark funds for anticipated spending, e.g. annual maintenance of parish assets and general parish upkeep

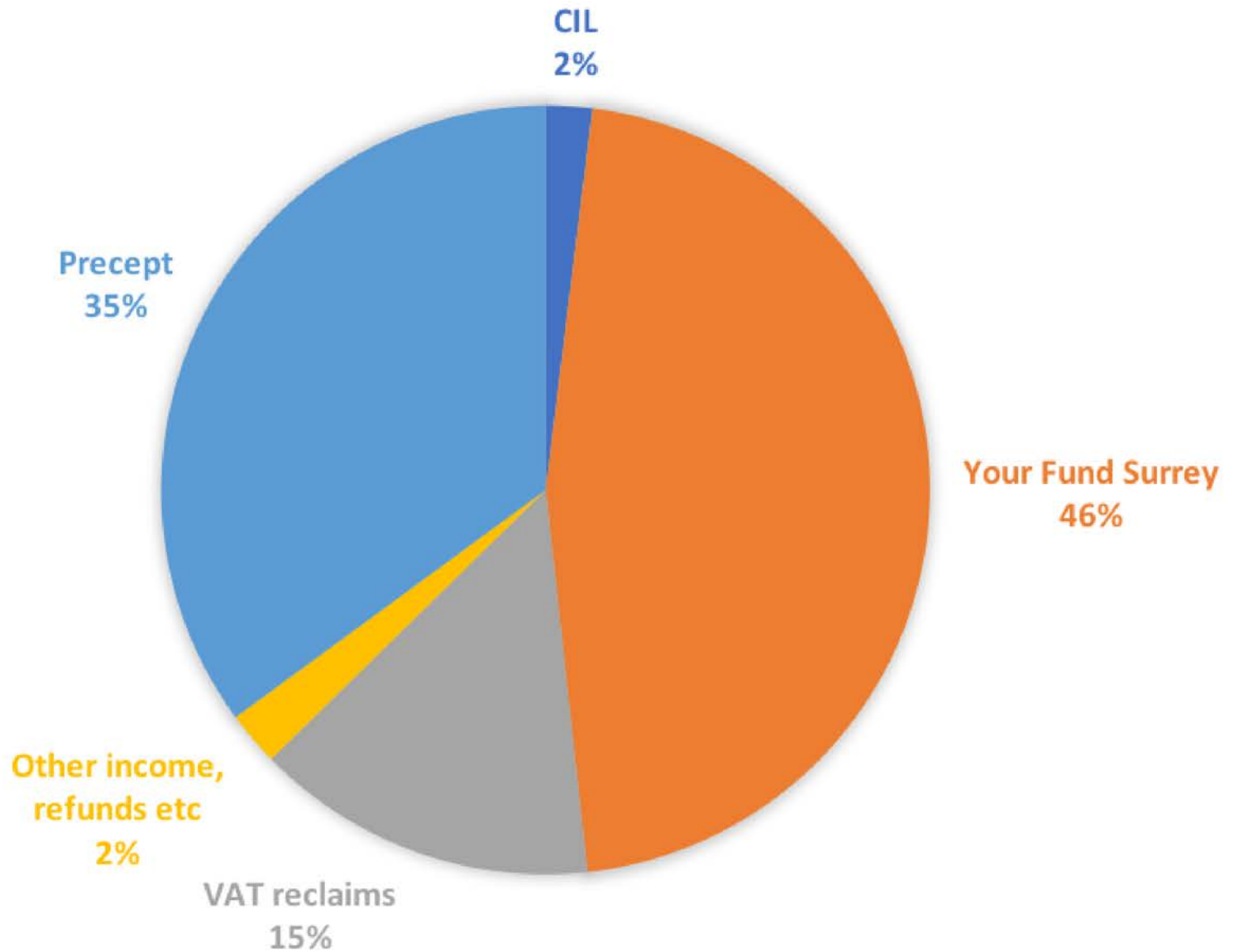




INCOME FY22/23

- Core Parish Council income (excluding YFS Grant) in 2022/23 was £51,005, comprising:
 - Precept £33,315
 - CIL £1,854
 - VAT reclaims £13,674
 - Other income, refunds etc £2,161
- Your Fund Surrey Grant was £44,000
- **Total audited income - £95,005**

EXPENDITURE FY22/23

- Overall approved (budgeted) expenditure for our Core activities (excluding Limpsfield Way Project) for FY22-23 was £54,104.
- Total actual expenditure (excluding Your Fund Surrey project) to 31 March 2023 was £41,034.
- Approximately £2,680 outstanding to pay
- **Therefore, £10,390 underspend (approx. 19%) for FY23.**

NB. Total audited expenditure £84,342 includes Your Fund Surrey/Limpsfield Way project

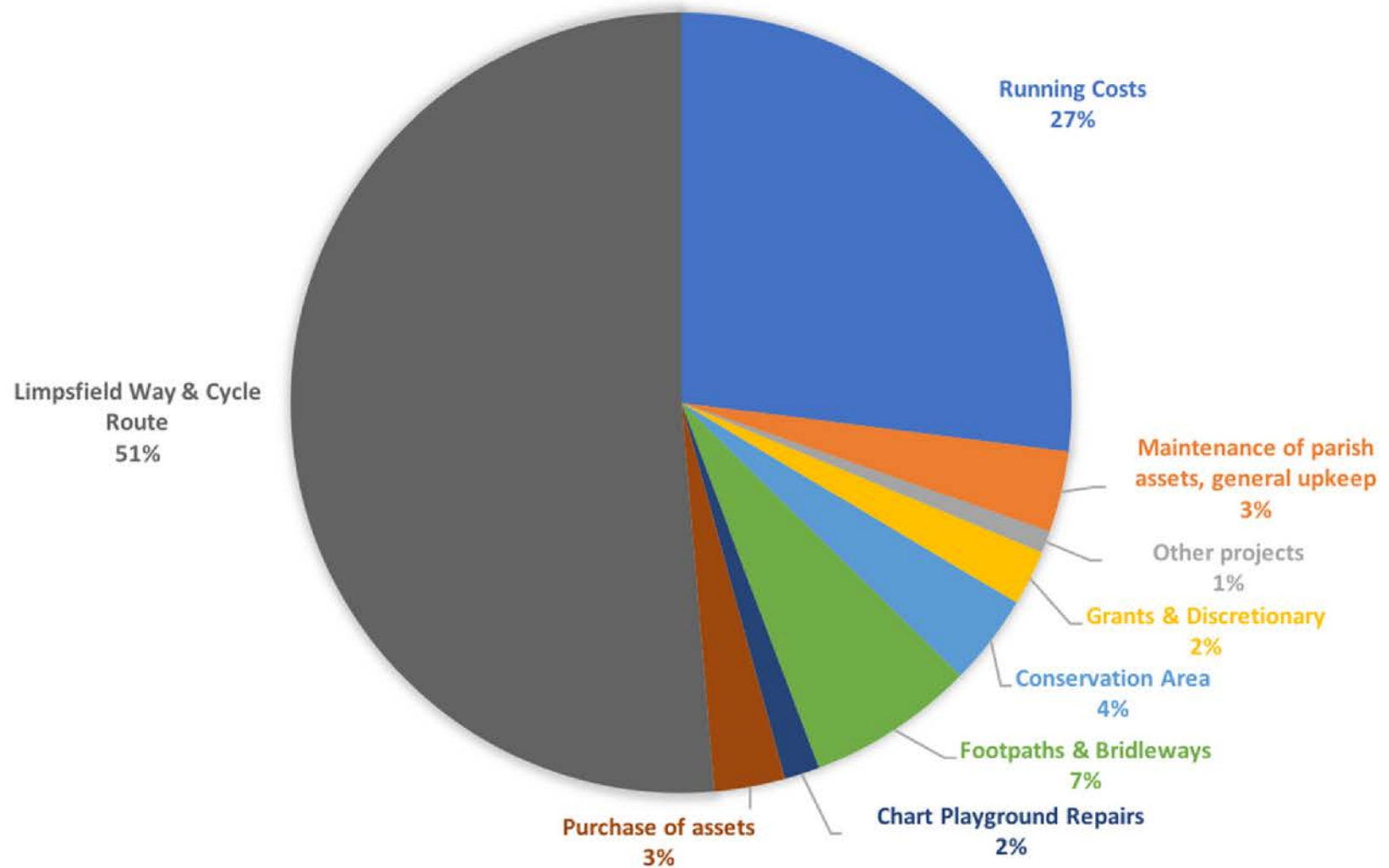

BUDGET OVERVIEW

- Approved Budget of proposed spending of £61,100, including general running costs, parish maintenance / upkeep, grants & discretionary items, and earmarked reserves:
 - £10,000 for Conservation Area enhancements
 - £10,000 for Village parking opportunities
 - £2,400 for Limpsfield Way/Cycle Route maintenance
 - £4,000 Footpaths & bridleways
